## 1. Executive Summary

### Vision

Building Asia's most comprehensive Web3 ecosystem for the entertainment industry, starting from Indonesia, with a focus on democratizing film funding through tokenization.

**Mission:** Enable anyone to participate in film production - whether as a creator seeking funding, or an investor seeking exposure to the entertainment industry with transparent, milestone-based protection.

### Problem Statement

3. Film Studio - Gamified Production Simulation

4.1 Overview

Film Studio is MGO's flagship gamified film production simulation - a play-to-earn experience where users own virtual cinemas, produce films, and earn MGO rewards through active engagement.

FILM STUDIO = GAMIFIED FILM PRODUCTION

Core Concept:

- └ Own and manage virtual cinemas
- └ Purchase film templates from marketplace
- └ Place films in production slots
- └ Perform marketing pushes to sustain production
- └ Earn MGO rewards based on activity
- └ Expand your cinema empire (up to 10 cinemas)

Key Features:

- └ Cinema ownership with expandable slots
- └ Film marketplace with various production tiers
- └ Marketing push mechanics (active engagement)
- └ Period-based earnings system
- └ MPlus integration for upgrades
- └ Batch withdrawal system

Status: Live and operational

4.2 Cinema Ownership

Users can own up to 10 virtual cinemas, each with production slots for films.

CINEMA SYSTEM

CINEMA STRUCTURE
------------------

Each Cinema Contains:

- 6 Production Slots
  - Slots 1-3: Unlocked by default
  - Slots 4-6: Require MPlus to unlock
- Individual balance tracking
- Push cost based on cinema number

Cinema Acquisition:

- Cinema #1: FREE (given to all users)
- Cinema #2: 10,000 MPlus
- Cinema #3: 15,000 MPlus
- Cinema #4: 20,000 MPlus
- ... (increasing cost per cinema)

Higher cinema numbers require larger push investments but can accommodate higher-tier film templates with greater earning potential.

4.3 Film Templates & Marketplace

Films are digital assets purchased from the marketplace and placed into cinema production slots.

INDIE	- Independent films, moderate investment

#### Template Parameters:

└ Price (MGO)	- Purchase cost

## 4.4 Marketing Push Mechanics

Marketing pushes are the core engagement mechanic - users must actively "push" their films to sustain production and earn rewards.

#### MARKETING PUSH SYSTEM

##### HOW PUSHES WORK

1. Each film has CLAIM PERIODS (e.g., 3-day periods)
2. Each period requires MINIMUM PUSHES (e.g., 3 pushes)
3. User must push at least once per PUSH INTERVAL
4. If push quota met → EARNINGS CREDITED
5. If push quota NOT met → FILM STOPS (early termination)

##### Push Payment Options:

- └ MGO Token (blockchain transaction)
- └ MPlus Credits (off-chain, instant)



Example Timeline (3-day claim period, 3 pushes required):

Day 1: Push #1 ✓
Day 2: Push #2 ✓
Day 3: Push #3 ✓ → Period Complete → Earnings Credited
Day 4: Push #1 (new period starts)

#### Push Economics:

- Push cost depends on cinema number (10-2,500 MGO)
- Higher-tier cinemas = higher push cost = higher earning films
- Missing push quota = film termination (no further earnings)
- Consistent engagement rewards consistent returns

## 4.5 Earnings & Withdrawals

### EARNINGS SYSTEM

#### BALANCE STATES

##### EARNING (Pending)

└ Locked in active films, awaiting period completion

##### AVAILABLE

└ Ready to withdraw, period completed successfully

##### WITHDRAWN

└ Already transferred to user's wallet

#### WITHDRAWAL PROCESS:

- └ Earnings automatically credited when period ends
- └ Available balance can be withdrawn anytime
- └ Batch withdrawal (all available in single transaction)
- └ Blockchain transaction to user's connected wallet
- └ No withdrawal fees (only gas fees)

#### Earnings Calculation:

Total Potential Earnings = (Duration ÷ Claim Interval) × Earnings Per Claim

Example:

- └ Film Duration: 90 days
- └ Claim Interval: 3 days
- └ Earnings Per Claim: 30 MGO
- └ Total Periods:  $90 \div 3 = 30$  periods
- └ Total Earnings:  $30 \times 30 = 900$  MGO

ROI = (Total Earnings - Purchase Price - Push Costs) ÷ Purchase Price × 100

## 4.6 MPlus Integration

MPlus is an off-chain credit system that enhances Film Studio functionality.

### MPLUS IN FILM STUDIO

---

#### MPlus Uses:

- └ Purchase additional cinemas (Cinema 2-10)
- └ Unlock production slots 4-6
- └ Pay for marketing pushes (alternative to MGO)
- └ Instant transactions (no blockchain wait)

#### MPlus Sources:

- └ Daily rewards from ecosystem activities
- └ NFT ownership bonuses
- └ Staking tier bonuses
- └ Special promotions
- └ Referral rewards

### Why Film Studio Matters:

#### ECOSYSTEM VALUE

---

##### For Users:

- └ Earn MGO through active engagement
- └ Gamified experience with strategic decisions
- └ Multiple revenue streams (multiple cinemas/films)
- └ Low entry barrier (free first cinema)

##### For Ecosystem:

- └ MGO token utility (purchases, pushes)
- └ Active user engagement and retention
- └ Token sink mechanism (push costs)
- └ Prepares users for \$MOVIE platform concepts

## 4. \$MOVIE Platform - Film Tokenization Launchpad

### 4.1 Platform Concept

#### \$MOVIE PLATFORM = FILM TOKENIZATION LAUNCHPAD

---

Platform Model: Crowdfunding meets DeFi for Film Production

Comparable to: Kickstarter + Republic (equity crowdfunding) + Web3

#### Core Mechanism:

- └ Creators submit film projects for community funding
- └ Platform auto-generates project-specific tokens
- └ Investors purchase tokens to support projects
- └ Funds released through milestone-based validation

└ Successful films distribute rewards to token holders

#### Key Differentiators vs Traditional Crowdfunding:

#### Key Innovation:

## 4.2 Token Relationship

#### Three-Layer Token Architecture:

**Why Unlimited Supply?** \$MOVIE is minted only through Forge (MGO conversion). This creates:

- Direct value linkage between MGO and \$MOVIE
- Natural supply based on ecosystem demand
- Deflationary pressure through fee burns
- No pre-mine or team allocation for \$MOVIE

### 4.3 Forge Mechanism

The Forge is the primary mechanism to acquire \$MOVIE tokens. It creates a direct value link between MGO and the film tokenization platform.

FORGE SYSTEM: MGO → \$MOVIE

FORGE POOLS

Pool 1: STANDARD FORGE (Instant)

Rate: 1 MGO = 10 \$MOVIE

Lock period: None

Processing: Instant conversion

MGO fate: 50% burned, 50% to treasury

Best for: Users who need \$MOVIE immediately

Pool 2: BOOSTED FORGE (30-Day Lock)

Rate: 1 MGO = 15 \$MOVIE (+50% bonus)

Lock period: 30 days

Processing: \$MOVIE released after lock expires

MGO fate: 60% burned, 40% to treasury

Best for: Medium-term planners

Pool 3: PREMIUM FORGE (90-Day Lock)

Rate: 1 MGO = 20 \$MOVIE (+100% bonus)

Lock period: 90 days

Bonus: Exclusive NFT airdrop included

MGO fate: 70% burned, 30% to treasury

Best for: Long-term ecosystem believers

ECONOMIC IMPACT:

Supply Reduction: 50-70% of forged MGO is permanently burned

- └ Treasury Building: Remaining MGO funds ecosystem development
- └ \$MOVIE Creation: Only way to mint new \$MOVIE tokens
- └ Price Support: Burns reduce MGO circulating supply over time

#### Example Calculation:

- User forges 1,000 MGO using Premium Forge
- User receives: 20,000 \$MOVIE (after 90-day lock)
- MGO burned: 700 MGO (70%)
- Treasury receives: 300 MGO (30%)

## 4.4 Production Tier System

The platform offers 3 production tiers to accommodate various creator levels, from first-time writers to established production houses. This hybrid model ensures quality while providing a clear growth path for creators.

### HYBRID PRODUCTION MODEL

#### TIER 1: STORY SUBMISSION (Production House Managed)

Target: Writers/storytellers without production experience

##### Creator Provides:

- └ Script or synopsis
- └ Story pitch (video/text)
- └ Community promotion and engagement
